Mr. Gagnon has sole voting power and sole dispositive power with respect to 176,455 shares of Common Stock held in the Personal Accounts and 489,720 shares of Common Stock held in the Fund, he shares voting power with certain persons other than GS with respect to 153,174 shares of Common Stock held in the Other Accounts and he shares dispositive power with certain persons other than GS with respect to 172,103 shares of Common Stock held in the Other Accounts. Except for Common Stock held in the Personal Accounts, Mr. Gagnon expressly disclaims beneficial ownership of all securities held in the Accounts, the Other Accounts and the Fund. No single client's interest as reported in the Accounts, the Personal Accounts, the Other Accounts or the Fund exceeds 5% of the Issuer's Common Stock.
