(SSF3) and Special Situations Fund III QP, L.P.* (SSFQP). Marx and Greenhouse are also members of SST Advisers, L.L.C. (SSTA), the general partner of and investment adviser to Special Situations Technology Fund, L.P. (Tech) and Special Situations Technology Fund II, L.P. (Tech II). (SSF3, SSFQP, Cayman, Tech and Tech II will hereafter be referred to as, the Funds). The principal business of each Fund is to invest in equity and equity-related securities and other securities of any kind or nature.
