As of the date of this Form 12b-25, the financial statements for the three months ended March 31, 2007 have not been completed due to the reasons stated above and will report a significant change in its earnings statement. The Registrant expects to report a change in its results of operations and a net loss of approximately \$877,000 in its first fiscal quarter ended March 31, 2007 as compared to net loss of \$1,313,718 for the first fiscal quarter ended March 31, 2006. The reduction in loss is primarily attributable to the Registrant reducing its expenses as a result of the completion of integration of its business since the merger with StorCOMM in November 2005.
