The matters intended to be acted upon at the meeting are listed below:

1. Election of directors: Marc L. Andreessen, Shumeet Banerji, Rajiv L. Gupta, John H. Hammergren, Raymond J. Lane, Ann M. Livermore, Gary M. Reiner, Patricia F. Russo, G. Kennedy Thompson, Margaret C. Whitman and Ralph V. Whitworth.
2. Ratification of the appointment of the independent registered public accounting firm for the fiscal year ending October 31, 2012.
3. Advisory vote on executive compensation.
4. Stockholder proposal entitled Executives to Retain Significant Stock.
5. Such other business as may properly come before the meeting.
