**Item 1.01 Entry into a Material Definitive Agreement.**

On April 24, 2019, AeroVironment, Inc. (the Company ) entered into an amendment to the Design and Development Agreement (the Amendment ) with HAPSMobile, Inc. Under the Amendment, the maximum net value of the Design and Development Agreement increased by \$38,675,443, for a total maximum net value of \$125,702,373. The total maximum net value excludes approximately \$6.0 million of consideration paid to the Company by SoftBank Corp. under preliminary design agreements related to the program.

The foregoing description of the Amendment does not purport to be complete and is qualified in its entirety by reference to the complete text of the amendments. The Company intends to seek confidential treatment for certain portions of all amendments entered into under the Design and Development Agreement. The Company will file the amendments as exhibits to its Annual Report on Form 10-K for the year ended April 30, 2019.
