(1) The option was fully vested and exercisable; however, the shares underlying the option are subject to an equity restriction agreement with SunPower pursuant to which such shares are subject to certain transfer and repurchase restrictions. The restrictions lapse on one quarter of the total underlying shares semi-annually during the two-year restriction period, so long as Mr. Ledesma remains employed by SunPower. 7,717 shares remain subject to transfer and repurchase restrictions until 12/30/08.
