These withheld shares are not sold on the open market and become Revlon, Inc. treasury shares.
- (2) Of the 21,981 shares beneficially owned, 16,667 shares are unvested restricted shares that the reporting person was granted on 05/18/09 which vest in substantially equal installments on 7/02/11 and 7/02/12.
