Item 1. Security and Issuer

This Amendment No. 1 (this "Amendment") amends, as set forth below, the statement on Schedule 13D, dated December 10, 2013 and filed with the SEC on December 12, 2013 (the "Original Schedule 13D") for Bank of America Corporation ("BAC") and Banc of America Preferred Funding Corporation ("BAPFC") (collectively, the "Reporting Persons") with respect to the variable rate munifund term preferred shares ("VMTP Shares") of Nuveen Dividend Advantage Municipal Fund (the "Issuer"). This Amendment is being filed as a result of: (a) the exchange (the "Exchange") of the Reporting Persons' 2,650 variable rate munifund term preferred shares (CUSIP No. 67066V804) for an equal number of variable rate munifund term preferred shares (CUSIP No. 67066V887) of the Issuer; and (b) the purchase (the "Purchase") by the Reporting Persons of 720 variable rate munifund term preferred shares (CUSIP No. 67066V887) from the Issuer.

Item 2. Identity and Background

Item 3. Source and Amount of Funds or Other Consideration

Item 3 of the Original Schedule 13D is hereby amended by adding the following paragraph at the end thereof:

"The Reporting Persons: (a) exchanged 2,650 variable rate munifund term preferred shares (CUSIP No. 67066V804) for an equal number of variable rate munifund term preferred shares (CUSIP No. 67066V887) of the Issuer (the "Exchange"); and (b) purchased 720 variable rate munifund term preferred shares (CUSIP No. 67066V887) from the Issuer (the "Purchase")."

The aggregate amount of funds used by the Reporting Persons for the Purchase was approximately \$72,000,000. The source of funds was the working capital of the Reporting Persons."

Item 4. Purpose of Transaction

Item 4 of the Original Schedule 13D is hereby amended by adding the following paragraph at the end thereof:

"BAPFC made the Purchase of the VMTP Shares for investment purposes. BAPFC acquired the VMTP Shares directly from the Issuer pursuant to a Purchase and Exchange Agreement, dated July 1, 2016, between the Issuer and BAPFC (the "Purchase and Exchange Agreement") on their initial issuance for a purchase price of \$72,000,000.

The Reporting Persons have not acquired the subject securities with any purpose, or with the effect of, changing or influencing control of the Issuer, or in connection with or as a participant in any transaction having that purpose or effect."
