**BANCOLOMBIA S.A. ANNOUNCES ITS INCLUSION IN THE DOW JONES SUSTAINABILITY WORLD INDEX**

Medellín, Colombia, September 13, 2012

Bancolombia announces its inclusion in the list of issuers tracked by the Dow Jones Sustainability World Index today, one of the main global indicators that monitor performance of leading companies in terms of corporate sustainability.
