(1) are earned. The shares are earned on a quarterly basis and are released to the independent directors on the last day of each fiscal quarter. Following the completion of the reporting person's service during the quarter, the shares shall be released as follows: (i) 1,218 shares were released on March 31, 2014; (ii) 1,219 shares shall be released on June 30, 2014; (iii) 1,219 shares shall be released on December 30, 2014; and (iv) 1,219 shares shall be released on December 31, 2014.
