(1) were granted on 2/6/04, with the shares vesting in equal portions over a 5-year period with the remaining two portions vesting in January of 2008 and 2009 and (iii) 1,540 Shares were granted to on 2/8/05, with the shares vesting in equal portions over a 5-year period with the remaining three portions vesting in January 2008, 2009 and 2010. Ms. Silverstein continues to beneficially own 5,626 of these Shares in the aggregate.
