- (1) This sale was effected pursuant to the terms of a Rule 10b5-1 trading plan adopted by the Reporting Person on December 13, 2013.
- (2) On August 6, 2013, the Reporting Person received a grant of restricted stock units ("RSUs") covering 13,350 shares of KLA-Tencor common stock. On August 6, 2014, the Reporting Person vested in twenty-five percent (25%) of such RSUs.
 Pursuant to the terms of the August 6, 2013 RSU grant, 1,742 shares of KLA-Tencor common stock were automatically withheld at vesting to cover required tax withholding. The fair market value of KLA-Tencor common stock used for purposes of calculating the number of shares to be withheld was the closing price of KLA-Tencor common stock as reported on the NASDAQ Stock Market on such vesting date.
- (3) Pursuant to the terms of the August 6, 2013 RSU grant, 1,742 shares of KLA-Tencor common stock were automatically withheld at vesting to cover required tax withholding. The fair market value of KLA-Tencor common stock used for purposes of calculating the number of shares to be withheld was the closing price of KLA-Tencor common stock as reported on the NASDAQ Stock Market on such vesting date.
- (4) Each RSU represents a contingent right to receive one share of KLA-Tencor common stock.
