(Global Resource), a direct beneficial owner of Common Stock, as set forth below, by the Trust; and (iv) by virtue of his positions with Resource Capital, ownership interest in the Trust and another indirect beneficial ownership interest in Common Stock, all as described in the following sentences, by Mr. Rule. Mr. Rule is President and a Director of Resource Capital, and, with his wife, is co-Trustee of the Trust, which owns 100% of Resource Capital and 100% of Rule Investments (as defined below). Mr. Rule s wife beneficially owns 20,000 shares of Common Stock, aggregating less than 1% of the Issuer s outstanding Common Stock.

Global Resource, which is not a Reporting Person, is the direct beneficial owner of 50,000 shares of Common Stock, aggregating less than 1% of the Issuer s outstanding Common Stock. The corporate General Partner of Global Resource is Rule Investments, Inc. (Rule Investments). The Trust owns 100% of Rule Investments.
