DEREGISTRATION OF SECURITIES

A.T. Massey Coal Company, Inc. (A.T. Massey) was originally incorporated in Richmond, Virginia in 1920 as a coal brokering business. In the late 1940s, A.T. Massey expanded its business to include coal mining and processing. In 1974, St. Joe Minerals acquired a majority interest in A.T. Massey. In 1981, St. Joe Minerals was acquired by Fluor Corporation (Old Fluor). A.T. Massey was wholly owned by Old Fluor from 1987 until November 30, 2000. On November 30, 2000, a reverse spin-off (the Spin-Off) was completed, which separated Old Fluor into two entities: the new Fluor Corporation (New Fluor) and Old Fluor which retained the coal-related businesses and was subsequently renamed Massey Energy Company (Massey). Massey has been a separate, publicly traded company since December 1, 2000.

This Post-Effective Amendment No. 1 (the Post-Effective Amendment), filed by Massey, removes from registration all securities registered under the following registration statements (each a Registration Statement, and collectively the Registration Statements) filed by Old Fluor with the Securities and Exchange Commission (the SEC) (note that the numbers listed below do not take into account corporate actions, such as stock splits, taken in the interim):

Registration Statement on Form S-8 (Registration No. 002-31720), originally filed with the SEC on February 14, 1969, registering 43,171 shares of common stock, \$0.625 par value per share, of the Company (the Common Stock) in connection with the Options to Purchase Stock of the Fluor Corporation, Ltd. Substituted for Options to Purchase Stock of Pike Corporation of America.

Registration Statement on Form S-8 (Registration No. 002-77532), originally filed with the SEC on May 17, 1982, registering 1,500,000 shares of Common Stock in connection with the 1971 Fluor Stock Option Plan, 1977 Fluor Executive Stock Plan, 1981 Executive Stock Plan and 1982 Fluor Incentive Stock Option Plan.

Registration Statement on Form S-8 (Registration No. 033-31440), originally filed with the SEC on October 6, 1989, registering 5,686,214 shares of Common Stock in connection with the 1988 Fluor Executive Stock Plan.

Registration Statement on Form S-8 (Registration No. 033-58557), originally filed with the SEC on April 14, 1995, registering 25,000 shares of Common Stock in connection with the Fluor Corporation Stock Plan for Non-Employee Directors

Registration Statement on Form S-8 (Registration No. 333-18151), originally filed with the SEC on December 18, 1996, registering 8,784,042 shares of Common Stock in connection with the 1996 Fluor Executive Stock Plan.

Registration Statement on Form S-8 (Registration No. 333-22157), originally filed with the SEC on February 21, 1997, registering 2,500,000 shares of Common Stock in connection with the 1988 Fluor Executive Stock Plan.

Registration Statement on Form S-8 (Registration No. 333-23809), originally filed with the SEC on March 21, 1997, registering 60,000 shares of Common Stock in connection with the 1997 Fluor Restricted Stock Plan for Non-Employee Directors.

Registration Statement on Form S-8 (Registration No. 333-37153), originally filed with the SEC on October 3, 1997, registering 145,000,000 shares of Common Stock in connection with the Fluor Executive Deferred Compensation Program.

Registration Statement on Form S-8 (Registration No. 333-32696), originally filed with the SEC on March 17, 2000, registering 3,700,000 shares of Common Stock in connection with the Fluor Corporation 1999 Executive Performance Incentive Plan.

Registration Statement on Form S-8 (Registration No. 333-37153), originally filed with the SEC on June 29, 2000, registering 1,000,000 shares of Common Stock in connection with the Fluor Corporation Employees Performance Plan.

On June 1, 2011, Alpha Natural Resources, Inc. (Alpha) completed its acquisition of the Company. Pursuant to the Agreement and Plan of Merger (the Merger Agreement), dated January 28, 2011, among the Company and Alpha and Mountain Merger Sub, Inc., a Delaware corporation and a wholly owned subsidiary of Alpha (Merger Sub), the Company was merged with and into Merger Sub (the Merger). The Company survived the Merger as a wholly owned subsidiary of Alpha. A Certificate of Merger was filed with the Delaware Secretary of State and the Merger became effective on June 1, 2011 (the Merger Date).

As a result of the Merger, the Company has terminated all offerings of its securities pursuant to its existing registration statements, including the Registration Statements. Accordingly, the Company hereby removes from registration the Common Stock registered but unsold under the Registration Statements as of the Merger Date.

Because each of these Plans was related to New Fluor, each Plan previously was transferred to New Fluor and/or terminated.
