LMMH acquired additional shares in a public offering by Issuer pursuant to a prospectus on SEC Form F-10, dated December 19, 2014 (the Registration Statement) at a price of US\$0.53 per share for a total purchase price for the shares acquired by LMMH in such public offering of approximately US\$28,000,960.00.

Item 4. Purpose of Transaction No Modification.

Item 5. Interest in Securities of the Issuer Item 5 is amended and restated as follows:

- (a) LMMH owns an aggregate amount of 145,854,411 shares of Platinum Group Common Stock, which constitutes approximately 19% of the 766,112,842 issued and outstanding shares of Platinum Group Common Stock.
- (b) LMMH has the sole power to vote or direct the vote of, and the sole power to dispose or direct the disposition of, 145,854,411 shares. LMMH has no shared power to either vote or dispose of the shares.
