**Item 1. Security and Issuer.**

This Amendment No. 7 amends the statement on Schedule 13D filed with the Securities and Exchange Commission ( SEC ) on May 14, 2004 as amended by Amendment No. 1 filed with the SEC on December 23, 2005, by Amendment No. 2 filed with the SEC on August 11, 2006, by Amendment No. 3 filed with the SEC on November 6, 2006, by Amendment No. 4 filed with the SEC on January 30, 2007, by Amendment No. 5 filed with the SEC on February 6, 2007 and by Amendment No. 6 filed with the SEC on July 26, 2007 (such schedule, as amended, the Schedule 13D ) by BCE Inc. ( BCE ) and 3787877 Canada Inc. ( 3787877 ) relating to the Class A Subordinate Shares (the Class A Shares ) of CGI Group Inc., a company incorporated under the laws of the Province of Québec (the Company ). This Amendment No. 7 is filed by BCE, the Bell Canada Pension Plan (the Plan ) and Bimcor Inc. ( Bimcor ), together with BCE and the Plan collectively referred to as the Reporting Persons and each as a Reporting Person ). The principal executive offices of the Company are located at 1130 Sherbrooke Street West, 7<sup>th</sup> Floor, Montréal, Québec, Canada, H3A 2M8. A joint filing agreement is attached hereto as Exhibit 1 to this Schedule 13D pursuant to Rule 13d-1(k) promulgated under the Securities Exchange Act of 1934, as amended (the Exchange Act ).

This Amendment No. 7 relates to the following sales of Class A Shares through the facilities of the Toronto Stock Exchange ( TSX ):

- (i) On August 21, 2007, the Plan sold 182,500 Class A Shares at \$10.56 per share;
- (ii) On August 22, 2007, the Plan sold 424,900 Class A Shares at \$10.79 per share;

- (iv) On August 24, 2007, the Plan sold 215,400 Class A Shares at \$10.82 per share;
- (v) On August 27, 2007, the Plan sold 80,500 Class A Shares at \$10.87 per share;
- (vi) On September 17, 2007, the Plan sold 308,600 Class A Shares at \$11.11 per share;
- (vii) On September 18, 2007, the Plan sold 308,600 Class A Shares at \$11.05 per share;
- (viii) On September 20, 2007, the Plan sold 85,000 Class A Shares at \$11.40 per share;
- (ix) On September 21, 2007, the Plan sold 245,100 Class A Shares at \$11.12 per share;
- (x) On November 19, 2007, the Plan sold 153,100 Class A Shares at \$10.82 per share and 35,300 Class A Shares at \$10.74 per share;
- (xi) On November 20, 2007, the Plan sold 111,600 Class A Shares at \$10.67 per share and 70,000 Class A Shares at \$10.64 per share;
- (xii) On November 21, 2007, the Plan sold 219,800 Class A Shares at \$10.79 per share;

- (xiii) On November 22, 2007, the Plan sold 30,200 Class A Shares at \$10.64 per share;
- (xiv) On November 26, 2007, the Plan sold 280,000 Class A Shares at \$10.68 per share and 100,000 Class A Shares at \$10.61 per share;
- (xv) On November 28, 2007, the Plan sold 189,500 Class A Shares at \$11.26 per share;
- (xvi) On November 30, 2007, the Plan sold 310,500 Class A Shares at \$11.35 per share;
- (xvii) On December 4, 2007, the Plan sold 200,000 Class A Shares at \$11.09 per share;
- (xviii) On December 5, 2007, the Plan sold 100,000 Class A Shares at \$11.65 per share and 400,000 Class A Shares at \$11.32 per share.

The above sales are herein collectively referred to as the Transactions .

The following amendments to Items 2, 4, 5, 6 and 7 of the Schedule 13D are hereby made.

**Item 2. Identity and Background.**

Item 2 of the Schedule 13D is hereby amended in its entirety to read as follows:

This Amendment No. 7 to Schedule 13D (this Amendment ) is being filed by the Reporting Persons.

The Plan is a registered pension plan organized under the laws of Canada, and is the pension plan that covers the employees of Bell Canada and certain of its subsidiaries (the Plan members ). Bell Canada, a corporation organized under the laws of Canada, is the sponsor and administrator of the Plan. Bimcor is a corporation organized under the laws of Canada that is a wholly-owned subsidiary of BCE and that manages independently from BCE the Plan s investments. BCE is a corporation organized under the laws of Canada.

The address of the principal place of business of BCE is 1000, rue de la Gauchetière Ouest, Bureau 3700, Montréal, Québec, Canada H3B 4Y7. The address of the principal place of business of Bell Canada, the Plan s sponsor and administrator, is 1000, rue de la Gauchetière Ouest, Bureau 3700, Montréal, Québec, Canada H3B 4Y7. The address of the principal place of business of Bimcor is 1000, rue de la Gauchetière Ouest, Bureau 1300, Montréal, Québec, Canada H3B 5A7.

The principal business activity of BCE is communications. The principal objective of the Plan is to pay pensions to Plan members when they terminate their employment with Bell Canada or its subsidiaries or, in the event of their death, to their designated beneficiaries. The principal business of Bimcor is the management of investments of the Plan and of investments of the pension plans of other BCE group companies. BCE is Canada s

largest communications company, providing the most comprehensive and innovative suite of communication services to residential and business customers in Canada. Under the Bell brand, BCE's services include local, long distance and wireless phone services, high-speed and wireless Internet access, IP-broadband services, information and communications technology services (or value-added services) and direct-to-home satellite and VDSL television services. BCE also holds an interest in CTVglobemedia, Canada's premier media company. BCE shares are listed in Canada and the United States.

Set forth on Schedules A-1 and A-2 to this Amendment, and incorporated herein by reference, are lists of the executive officers and directors of BCE and Bimcor that contain the following information with respect to each such person: (i) name; (ii) residence or business address; (iii) principal occupation or employment (and address of corporation or other organization in which such employment is conducted); and (iv) citizenship.

During the last five years, none of the Reporting Persons and, to the best of the knowledge of BCE and Bimcor, none of the persons named on Schedules A-1 and A-2 hereto, has been convicted in a criminal proceeding (excluding traffic violations or similar misdemeanors) or has been a party to a civil proceeding of a judicial or administrative body of competent jurisdiction as a result of which such person was or is subject to a judgment, decree or final order enjoining future violations of, or prohibiting or mandating activities subject to, federal or state securities laws or finding any violation with respect to such laws.

**Item 4. Purpose of Transaction.**

Item 4 of the Schedule 13D is hereby amended in its entirety to read as follows:

The Transactions were made in the ordinary course of business.

BCE has no current intention to acquire additional securities of the Company. However, BCE reserves the right to change its plans and intentions with respect to the Company at any time and BCE may, from time to time, sell or acquire Class A Shares (or other securities of the Company) in public or private transactions.

The matters set forth in Item 6 below are incorporated in this Item 4 by reference as if fully set forth herein.

Except as set forth in this Item 4 (including the matters described in Item 6 which are incorporated in this Item 4 by reference), the Reporting Persons have no present plans or proposals that relate to, or that would result in, any of the actions specified in clauses (a) through (j) of Schedule 13D of the Exchange Act.

**Item 5. Interest in Securities of the Issuer.**

Item 5 of the Schedule 13D is hereby amended in its entirety to read as follows:

(a) Giving effect to the Transactions, BCE, the Plan and Bimcor are the beneficial owners of 14,139,761 Class A Shares representing 4.88% of the outstanding Class A Shares. The calculation of the foregoing percentage is based on the approximately 289.9 million Class A Shares outstanding on December 5, 2007.

(b) Giving effect to the Transactions, BCE has the sole power to vote or to direct the vote or dispose or direct the disposition of no Class A Shares. Giving effect to the Transactions, the Plan and Bimcor have the shared power to vote or to direct the vote or dispose or direct the disposition of 14,139,761 Class A Shares. Giving effect to the Transactions, BCE may be considered to have the shared power to vote or to direct the vote or dispose or direct the disposition of 14,139,761 Class A Shares. However, BCE disclaims beneficial ownership of the Class A Shares held by the Plan.

To the best of the knowledge of BCE and Bimcor, the following persons named on Schedules A-1 or A-2 beneficially own the following amounts of Class A Shares and have sole voting power and sole dispositive power with respect to such shares (in each case the amount of Class A Shares accounts for less than 1% of the total outstanding amount of Class A Shares):

(c) No transactions, other than the Transactions, were effected in the past sixty days in this class of securities by the Reporting Persons.

To the best of the knowledge of BCE and Bimcor, there were no transactions effected in the past sixty days in this class of securities by any of the persons named on Schedules A-1 and A-2 hereto.

(d) No person is known to have the right to receive or the power to direct the receipt of dividends from, or the proceeds from the sale of, Class A Shares held by the Reporting Persons or the persons named on Schedules A-1 or A-2 other than each of the Reporting Persons or such persons named on Schedules A-1 or A-2.

(e) The Reporting Persons ceased to be the beneficial owners of more than five percent of the Class A Shares on December 5, 2007.

**Item 6. Contracts, Arrangements, Understandings or Relationships With Respect to Securities of the Issuer.**

Item 6 of the Schedule 13D is hereby amended in its entirety to read as follows:

The response to Item 4 of this Schedule 13D is incorporated herein by reference.

BCE and its wholly-owned subsidiaries holding any Class A Shares or Class B Shares or other securities of the Company (collectively, Securities ) have certain registration rights with respect to the Securities held by them pursuant to the terms and conditions set forth in the Registration Rights Agreement entered into as of July 1, 1998 among BCE, Bell Canada and the Company (the Registration Rights Agreement ).

This description of the Registration Rights Agreement is qualified in its entirety by reference to the Registration Rights Agreement, a copy of which has been filed as Exhibit 5 to this Schedule 13D on May 14, 2004 and is incorporated herein by reference.

Except as described above or elsewhere in this Amendment or incorporated by reference in this Amendment, there are no contracts, arrangements, understandings or relationships (legal or otherwise) between any of the Reporting Persons or, to the best of their knowledge, any of the other persons named in Item 2 and between such persons and any person with respect to any securities of the Company, including but not limited to transfer or voting of any of the securities, finder's fees, joint ventures, loan or option arrangements, puts or calls, guarantees of profits, division of profits or loss or the giving or withholding of proxies.

**Item 7. Material to be filed as Exhibits.**

Item 7 of the Schedule 13D is hereby amended by the addition of the following exhibits to the end thereof:

Exhibit 1: Joint Filing Agreement dated December 11, 2007 among BCE Inc., Bell Canada, in its capacity as administrator of the Bell Canada Pension Plan and Bimcor Inc.
