Represents 5,047 Restricted Stock Units ("RSUs") that were granted on February 22, 2007, 1,666 of which vested on February 22, 2008 (a non-reportable event) and 3,381 of which have not yet vested. The grant of these RSUs was previously and timely reported in Table II.
- (1) The Issuer's method of reporting RSU grants (which may be settled only in Issuer stock) has been revised to report such grants in Table I rather than as previously reported in Table II. The RSUs vest in three equal installments beginning on the first anniversary of the date of grant.
