(7) The shares underlying the restricted stock unit vest as follows: 25% of the shares vested on September 11, 2014, 25% of the share vest on December 11, 2014, 25% of the shares vest on March 11, 2015 and 25% of the shares vest on the earlier of June 10, 2015 or the date of the Issuer's next annual meeting, subject to continued service to the Issuer through the applicable vesting date.
