- (1) Each restricted stock unit represents a contingent right to receive 1 share of the issuer's Class A Common Stock upon vest.
- (2) On June 11, 2015 the Compensation Committee of the Issuer approved the acceleration of 26,667 restricted stock units of the Reporting Person.  
The shares underlying the restricted stock unit vest as follows: 25% of the shares vest on September 11, 2014, 25% of the shares vest on December 11, 2014, 25% of the shares vest on March 11, 2015 and 25% of the shares vest on the earlier of June 10, 2015 or the date of the Issuer's next annual meeting, subject to continued service to the Issuer through the applicable vesting date.
- (3) The shares underlying the restricted stock unit vest as follows: one third of the shares vest on the one year anniversary of the vest start date (August 15, 2012) and an additional one third of the shares vest on each subsequent anniversary thereafter over the remaining 2 years.
- (4) The shares underlying the restricted stock unit vest as follows: one third of the shares vest on the one year anniversary of the vest start date (August 15, 2012) and an additional one third of the shares vest on each subsequent anniversary thereafter over the remaining 2 years.
