On February 4, 2014, the reporting person reported the grant of certain market restricted stock units (the "MRSUs"). The MRSUs have a service-based vesting component as well as a Total Shareholder Return Multiplier. On February 1, 2016, pursuant to the terms of the service-based vesting component of the MRSUs, the second tranche of such award vested. Based upon the Total Shareholder Return

- Service-based vesting component of the WRSDS, the second trainer of such award vested. Based upon the Total shareholder Return Multiplier, the reporting person received 695 additional shares of the Company's restricted stock, such shares representing the amount vested in excess of the target amount of MRSUs initially reported on Form 4 in February 2014. In addition, the reporting person received 115 shares of the Company's restricted stock through the accrual of dividend equivalents.
