OF THE MEETING OF THE BOARD OF DIRECTORS

HELD ON JUNE 26TH, 2018

- **1. DATE, TIME AND PLACE:** on June 26th, 2018, at 11:00 a.m., at the head offices of Companhia Brasileira de Distribuição ("Company"), at Avenida Brigadeiro Luís Antônio, No. 3.142, City and State of São Paulo.
- **2. CONDUCTION OF THE MEETING:** <u>Chairman</u>: Mr. Jean-Charles Henri Naouri; <u>Secretary</u>: Mrs. Ana Paula Tarossi Silva.
- 3. CALL TO ORDER AND ATTENDANCE: The call notice was waived pursuant to paragraph second of article 15 of the Company's Bylaws and sole paragraph of article 9 of the Internal Regulation of the Company's Board of Directors. Were present all of the members of the Board of Directors, namely, Messrs. Jean-Charles Henri Naouri, Arnaud Daniel Charles Walter Joachim Strasser, Ronaldo Iabrudi dos Santos Pereira, Carlos Mario Giraldo Moreno, Eleazar de Carvalho Filho, Jose Gabriel Loaiza Herrera, Luiz Augusto de Castro Neves, Luiz Nelson Guedes de Carvalho and Manfred Heinrich Gartz.
- **4. AGENDA**: (i) Analysis and deliberation on the reorganization of the Company's logistics footprint, including the sale of assets; and (ii) Analysis and deliberation on the sale of tax credits.

- **5. RESOLUTIONS:** As the meeting was commenced, the Board of Director's members examined the items comprised in the Agenda and resolved, unanimously and without reservations:
- **5.1.** Analysis and deliberation on the reorganization of the Company's logistics footprint, including the sale of assets: the Company's Management presented a proposal for the reorganization of the Company's logistics footprint. In this sense, as one of the stages in the reorganization of the Company's logistics footprint, the Company's Management presented a proposal for the sale of assets related to the current structure, namely the Distribution Center 01, located at Anhanguera Highway, KM 17.8, and the Distribution Center 04, located at Jaraguá Tourist Road, no. 50. Following the explanations provided by the Company's Management pursuant to the presentation made, the Board Members decided to approve the sale of the Distribution Centers 01 and 04, based on the favorable recommendation of the Financial Committee.
- **5.2.** Analysis and deliberation on the sale of tax credits: the Company's Management presented a proposal for the sale of tax credits arising from the exclusion of ICMS from the PIS / COFINS calculation bases, related to generating events occurred in 2011, which are subject to judicial discussion, for the amount of R\$ 50 million. After discussions, the Board Members resolved to approve the sale of the said tax credits by the Company, based on the favorable recommendation of the Financial Committee.
- **6. APPROVAL AND SIGNATURE OF THESE MINUTES:** As there were no further matters to be addressed, the meeting was adjourned so that these minutes were drawn up.
