- (1) Each Restricted Share Unit ("RSU") represents the right to receive without payment to the Company, one newly-issued, fully paid and non-assessable common share of the Company, subject to the terms and conditions of the RSU Plan and the grant certificate evidencing each grant. In the discretion of the Compensation Committee, upon vesting the value of the RSU grant alternatively may be paid in cash, or partly in common shares.
- (2) The reporting person is CEO of Haverford Investment Management (GP), Limited and disclaims beneficial ownership of these shares.
- (3) The RSUs vest 100% on the date of grant and do not have an expiration date.
