 - (1) On March 14, 2016, 90,000 performance-vesting restricted share units held by Mr. Durkin vested and, as allowed under the terms of his restricted share unit agreement, the Company withheld 46,962 shares otherwise deliverable to him to satisfy the resulting tax withholding obligations.
 - (2) On March 14, 2016, 87,500 restricted share units held by Mr. Durkin vested and, as allowed under the terms of his restricted share unit agreement, the Company withheld 45,658 shares otherwise deliverable to him to satisfy the resulting tax withholding obligations.
 - (3) Following the transactions reported on this Form 4, Mr. Durkin held 177,500 restricted stock units, 90,000 of which have vesting tied to performance, each representing the right to receive one share of the Company's common stock, and 258,925 shares of the Company's common stock.
