MPC announced today that it filed on June 1, 2018, its premerger notification and report form with respect to its proposed merger with Andeavor under the Hart-Scott-Rodino Antitrust Improvements Act of 1976 with the Federal Trade Commission and the Antitrust Division of the U.S. Department of Justice. On June 1, 2018, MPC also submitted an application for Competition Bureau Canada approval for the merger. The completion of the merger is subject to the receipt of antitrust clearance in the United States and obtaining regulatory approval in Canada, among other conditions.
