Sabby Management, LLC and Hal Mintz do not directly own any shares of Common Stock, but each indirectly owns 9,903,343 shares of Common Stock. Sabby Management, LLC, a Delaware limited liability company, indirectly owns 9,903,343 shares of Common Stock because it serves as the investment manager of Sabby Healthcare Master Fund, Ltd. Mr. Mintz indirectly owns 9,903,343 shares of Common Stock in his capacity as manager of Sabby Management, LLC.
