Item 1. Security and Issuer

This Amendment No. 2 (this "Amendment") amends, as set forth below, the statement on Schedule 13D, dated September 1, 2015 and filed with the SEC on September 3, 2015 (the "Original Schedule 13D"), as amended by Amendment No. 1 dated December 19, 2018 and filed with the SEC on December 21, 2018 ("Amendment No. 1"), for Bank of America Corporation ("BAC"), Banc of America Preferred Funding Corporation ("BAPFC"), and Blue Ridge Investments, L.L.C. ("Blue Ridge") (collectively, the "Reporting Persons") with respect to the variable rate munifund term preferred shares ("VMTP Shares") of AllianceBernstein National Municipal Income Fund, Inc. (the "Issuer").

This Amendment is being filed as a result of the transfer by Blue Ridge of 1,548 VMTP Shares (CUSIP No. 01864U502), representing all the VMTP Shares owned by Blue Ridge, to BAPFC (the "Transfer"). Prior to the Transfer BAPFC held 5,644 VMTP Shares (CUSIP No. 01864U403) and 1,983 VMTP Shares (CUSIP No. 01864U502) and following the transfer BAPFC holds 9,175 VMTP Shares, representing all the VMTP Shares of the Issuer.

Item 2. Identity and Background

- (a) Item 2 of the Original Schedule 13D is hereby amended by deleting Schedule I and Schedule II referenced therein and replacing them with Schedule I and Schedule II included with this Amendment.

Item 2 of the Original Schedule 13D is further amended by deleting paragraphs (a), (b) and (c) thereof and replacing them with following:

"(a) This Statement is being filed on behalf of each of the following persons (collectively, the "Reporting Persons"):

- i. Bank of America Corporation ("BAC")
- ii. Banc of America Preferred Funding Corporation ("BAPFC")

This Statement relates to the VMTP Shares that were purchased for the account of BAPFC and Blue Ridge.

Item 3. Source and Amount of Funds or Other Consideration

Item 3 of the Original Schedule 13D is hereby amended by adding the following paragraph at the end thereof:

"BAPFC purchased from Blue Ridge 1,548 variable rate munifund term preferred shares (CUSIP No. 01864U502) (the "Purchase").

The aggregate amount of funds used by BAPFC for the Purchase was approximately \$38,700,000. The source of funds was the working capital of BAPFC."

Item 4. Purpose of Transaction

Item 4 of the Original Schedule 13D is hereby amended by adding the following paragraph at the end thereof:

"BAPFC made the Purchase of 1,548 VMTP Shares (CUSIP No. 01864U502) from Blue Ridge for investment purposes. BAPFC acquired the 1,548 VMTP Shares (CUSIP No. 01864U502) from Blue Ridge pursuant to a Purchase and Assignment Agreement, dated March 14, 2019, between the BAPFC and Blue Ridge (the "Purchase Agreement") for a purchase price of \$38,700,000.

The Reporting Persons have not acquired the subject securities with any purpose, or with the effect of, changing or influencing control of the Issuer, or in connection with or as a participant in any transaction having that purpose or effect."

"The voting and consent rights on the 1,548 VMTP Shares purchased by BAPFC from Blue Ridge will continue to be treated in the same manner as previously described in this Item 6 except that the rights previously described as held by BAPFC and Blue Ridge are now held entirely by BAPFC."
