(1) Lattice option valuation model was used to estimate the fair value of the option. This model requires the input of certain assumptions, including risk-free interest rate, volatility, dividend yield, and expected life. The formula for determining the number of options granted is: $\text{number of options} = (\text{base pay} \times \text{LTI}\%) / \text{option fair value}$.

(2) This Form 4 is being amended to report the number of options granted, which was unknown at the time of the original filing on 3/1/2010, pursuant to a formula approved by the Compensation Committee.
