TEVA RECEIVES TENTATIVE APPROVAL FOR GENERIC PROTONIX® DELAYED RELEASE TABLETS, 20 MG AND 40 MG

Jerusalem, Israel, April 21, 2006 - Teva Pharmaceutical Industries Ltd. (Nasdaq: TEVA) announced today that the U.S. Food and Drug Administration has granted tentative approval for the Company's Abbreviated New Drug Application (ANDA) to market its generic version of Wyeth's Protonix® (Pantoprazole Sodium) Delayed Release (DR) Tablets, 20 mg and 40 mg.

Upon final approval, Teva's Pantoprazole Sodium DR Tablets will be the AB-rated equivalent of Protonix® DR Tablets, a product indicated for short term treatment of erosive esophagitis associated with GERD, maintenance of healing of erosive esophagitis and for treatment of hypersecretory conditions.

Annual brand product sales in the U.S. were approximately \$2.4 billion for the twelve months ended December 2005.

Teva is currently in patent litigation concerning this product in the U.S. District Court for the District of New Jersey. A suit was brought against Teva in May 2004 involving Teva's paragraph IV certification to U.S. Patent No. 4,758,579. A trial date has not been set.

Final approval is expected upon the earlier of a favorable decision in the case or expiry of the mandatory stay of approval in August 2007.

Teva Pharmaceutical Industries Ltd., headquartered in Israel, is among the top 20 pharmaceutical companies in the world and is the leading generic pharmaceutical company. The company develops, manufactures and markets generic and innovative human pharmaceuticals and active pharmaceutical ingredients, as well as animal health pharmaceutical products. Close to 90% of Teva's sales are in North America and Europe.
