# CABLEVISION RECEIVED FINANCING FOR BESTEL ACQUISITION

Mexico City, December 21, 2007 – Grupo Televisa, S.A.B. ("Televisa"; NYSE:TV; BMV:TLEVISA CPO), announced today, that its subsidiary Empresas Cablevisión, S.A.B. de C.V. ("Cablevisión"; BMV: CABLE), entered into a 5-year term syndicated loan facility for US\$225 million in connection with the financing of the acquisition of the majority of the assets of Bestel, S.A. de C.V.

Grupo Televisa, S.A.B., is the largest media company in the Spanish-speaking world and a major participant in the international entertainment business.
