Pursuant to Rule 13d-2 promulgated under the Act, this Amendment No. 1 to Schedule 13D (this <u>"Amendment No. 1"</u>) is being filed with respect to the common stock, par value \$0.0001 per share (the <u>"Common Stock"</u>), of Halcón Resources Corporation, a Delaware corporation (the <u>"Issue</u>r"), to amend the Schedule 13D filed on October 22, 2018 (the <u>"Original 13D"</u> and, as amended by this Amendment No. 1, the <u>"Schedule 13D"</u>). Capitalized terms used but not otherwise defined herein shall have the meanings ascribed to them in the Schedule 13D.

Item 4. PURPOSE OF THE TRANSACTION

Item 4 of this Schedule 13D is hereby amended and supplemented to include the following:

On February 4, 2019, Fir Tree sent an open letter to the Board of Directors of the Issuer (the <u>"Board"</u>), issued in the form of a press release (the <u>"February Press Release"</u>), stating, among other things, that Fir Tree is considering running a proxy contest at the Issuer's next annual meeting unless immediate action is taken to (x) appoint two new independent directors to lead a strategic process to sell the Issuer for cash and/or stock and (y) significantly reduce excessive general and administrative expense. The February 4th Press Release attaches a presentation related to the foregoing propositions (the <u>"February Presentation"</u>). The foregoing summaries of the February Press Release and February 4th Presentation are qualified in their entireties by the full texts of the February 4th Press Release and February 4th Presentation, which are filed as <u>Exhibit 3</u> and <u>Exhibit 4</u>, respectively, to this Schedule 13D, and are incorporated herein by reference.
