The Proposed Maximum Offering Price Per Share of Common Stock for the options issued under the SAR Plans and the restricted stock issued under the RS Plan were converted to U.S. dollars based on the average of the New York foreign exchange rate of \$106.87 = \$1.00 as quoted on February 23, 2018 by Reuters and other sources and published in the Wall Street Journal on February 23, 2018.

The Company has in place a directors' and officers' liability insurance policy, which indemnifies our directors and officers against liability arising from certain acts performed by them in their respective capacities as such.
