Winemiller Jr. 2006 Irrevocable Trust, (iii) 35,000 shares held of record by Debra Ann Winemiller, (iv) stock options to acquire 150,000 shares, which are immediately exercisable and which vest as to 25% on April 2, 2008 and the remainder monthly thereafter based on continued employment through April 2, 2011 and (v) 69,000 stock appreciation rights which are fully vested. Mr. Winemiller disclaims beneficial ownership of the shares held of record by Albert E. Winemiller Jr. 2006 Irrevocable Trust and Debra Ann Winemiller.
