**Introductory Note**

We are filing this Amendment No. 1 to our Quarterly Report on Form 10-Q for the quarter ended June 30, 2006 (the Second Quarter 2006 10-Q ), which was originally filed on July 28, 2006, to revise certain disclosures concerning our internal controls and procedures in Part I, Item 4, based on an SEC request. This request was one element of a review by the Division of Corporation Finance of the SEC of our quarterly report on Forms 10-Q filed during 2006. We have received and responded to the various SEC staff comments.

This Form 10-Q/A does not affect the Company's Consolidated Financial Statements or related Notes, or other information as presented in our Second Quarter 2006 10-Q. This Form 10-Q/A does not reflect events that have occurred after the Second Quarter 2006 10-Q was originally filed or update the information set forth in the Second Quarter 2006 10-Q originally filed for matters that occurred subsequent to such original filing date.

**Item 4. Controls and Procedures**

Under the supervision and with the participation of the Company's Chief Executive Officer and Chief Financial Officer, management of the Company has evaluated the effectiveness of the design and operation of the Company's disclosure controls and procedures (as defined in Rules 13a-15(e) and 15d-15(e) under the Securities Exchange Act of 1934) as of June 30, 2006 ( Evaluation Date ).
