## EXPLANATORY NOTE

On November 2, 2001, each of the Registrants filed with the Securities and Exchange Commission (the Commission ) a Registration Statement on Form S-3, Registration Statement No. 333-72712 (as subsequently amended by a Pre-Effective Amendment No. 1 to Form S-3 Registration Statement filed with the Commission on November 14, 2001 and a Pre-Effective Amendment No. 2 to Form S-3 Registration Statement filed with the Commission on December 5, 2002, the Registration Statement ), registering an aggregate amount of up to \$500,000,000 of the Registrant s common stock, junior subordinated debt securities, debt securities and/or trust preferred securities and guarantees with respect to the trust preferred securities. In January 2002, BancorpSouth Capital Trust I and BancorpSouth, Inc. offered and sold \$125,000,000 in aggregate amount of trust preferred securities and guarantees related to the trust preferred securities, pursuant to the Registration Statement.

In accordance with the undertaking made by the Registrants in the Registration Statement to remove from registration, by means of a post-effective amendment, any of the securities that remained unsold at the termination of the offering, the Registrants are filing this Post-Effective Amendment No. 1 and hereby remove from registration \$375,000,000 aggregate principal amount of common stock, junior subordinated debt securities, debt securities, trust preferred securities and guarantees with respect to the trust preferred securities that remain unsold under the Registration Statement. As a result of this deregistration, no securities remain registered for sale pursuant to the Registration Statement.
