8.01 Other Events

As of August 17, 2012, holders of the September 15, 2015 series of Zions Bancorporation subordinated notes (CUSIP: 989701AJ6), which are convertible into the Company's Series A or Series C preferred stock, filed notice of their election to convert a combined \$5.4 million principal amount of these notes into 215,440 depositary shares each representing a 1/40th interest in a share of the Company's Series C preferred stock. As a result of the elected conversions, the Company expects an additional 5,386 shares of Series C preferred stock will be issued when the conversions close on September 17th 2012, unless the elections are revoked prior to that date.

The expected discount amortization attributable to the conversions (i.e. accelerated discount amortization) is approximately \$2.0 million (pretax), which compares to the accelerated discount amortization for the second quarter 2012 conversions of \$16.2 million (pretax). The third quarter 2012 conversion expense would result in net interest margin pressure of two basis points, using the average earning assets of the second quarter of 2012, which compares to actual conversion-related net interest margin pressure of 13 basis points in the second quarter of 2012. The after-tax cost associated with the third quarter 2012 conversion is expected to be \$1.6 million.

Upon the close of the conversions noticed this quarter, the cumulative amount of subordinated notes converted since the debt was modified in June 2009 to include the conversion feature will equal \$747.9 million, of which approximately \$747.2 million will have been converted into the Company's depositary shares representing Series C preferred stock and \$0.7 million will have been converted into depositary shares representing the Company's Series A preferred stock, equaling 29,885,440 depositary shares of Series C preferred stock and 28,640 depositary shares of Series A preferred stock. In aggregate, 747,136 shares of Series C and 716 shares of Series A preferred stock will have been issued. The aggregate conversions are expected to constitute approximately 61.8% of the original \$1.21 billion principal amount of the convertible subordinated notes; the \$1.21 billion includes the December modification of \$40 million of subordinated debt, as referenced in the Form 8-K filed January 5, 2010.

The expected remaining balance of convertible subordinated debt is \$462.0 million (par value); it is expected that the unamortized discount on this debt will be approximately \$161.4 million as of September 30, 2012.

The conversion dates for the convertible subordinated notes occur only on semi-annual interest payment dates. The next such dates are:

- · November 15, 2012 for convertible 5.65% notes due on May 15, 2014;
- · November 16, 2012 for convertible 5.50% notes due on November 16, 2015;
- · March 15, 2013 for convertible 6.00% notes due on September 15, 2015.
