On December 12, 2012, American Realty Capital Trust, Inc. (the "Company") released an investor presentation and issued a press release in connection with the Company's Special Meeting of Stockholders scheduled for January 16, 2013, to consider and vote on, among other things, a proposal to approve the merger of the Company with and into Tau Acquisition LLC, a Delaware limited liability company and a direct wholly owned subsidiary of Realty Income Corporation, a Maryland corporation ("Realty").

American Realty Capital Trust, Inc., a publicly traded Maryland corporation listed on The NASDAQ Global Select Market under the trading symbol "ARCT", is a leading self-administered real estate company that owns and acquires single tenant free standing commercial real estate properties that are primarily net leased on a long-term basis to investment grade rated and other creditworthy tenants.
