- (5) such grant shall vest in 2 equal installments on October 1, 2018 and 2020, subject to the Reporting Person's continuous service through such application vesting date.
- This is the first of 4 vesting installments of RSU's granted to the Reporting Person on November 14, 2016. The remaining 4071 shares
- (6) from such grant shall vest in 3 equal installments on October 1, 2018, 2019 and 2020, subject to the Reporting Person's continuous service through each application vesting date.
