Item 3.03 Material Modification to Rights of Security Holders

Upon issuance of the Series G Preferred Stock (defined in Item 5.03 below) on February 7, 2013, the ability of Zions Bancorporation (the Registrant) to declare or pay dividends on, or purchase, redeem or otherwise acquire, shares of its common stock will be subject to certain restrictions in the event that the Registrant fails to pay dividends on its Series G Preferred Stock. These restrictions are set forth in the Articles of Amendment establishing the terms of the Series G Preferred Stock, a copy of which is listed as Exhibits 3.1 and 4.1 to this Current Report on Form 8-K and is incorporated herein by reference.

Item 5.03 Amendment to Articles of Incorporation or Bylaws; Change in Fiscal Year

On February 6, 2013, the Registrant filed Articles of Amendment to its Restated Articles of Incorporation with the Utah Division of Corporations and Commercial Code, setting forth the terms of its Series G Fixed/Floating Rate Non-Cumulative Perpetual Preferred Stock, liquidation preference \$1,000 per share (the Series G Preferred Stock). A copy of the Articles of Amendment relating to the Series G Preferred Stock is listed as Exhibits 3.1 and 4.1 to this Current Report on Form 8-K and is incorporated herein by reference.

Item 8.01 Other Events

On January 31, 2013, the Registrant issued a press release, announcing the pricing of its public offering of depositary shares (the Depositary Shares), each representing a 1/40th interest in a share of the Company s Series G Preferred Stock. A copy of the press release is attached hereto as Exhibit 99.1 and is incorporated herein by reference.
