On September 16, 2016, Esterline Technologies Corporation (the Company) entered into a letter agreement (the Agreement) with First Pacific Advisors, LLC and certain of its affiliates (FPA) regarding ongoing discussions between the Company and FPA relating to FPA sownership of shares of the Company soutstanding common stock (Common Stock) and certain other governance matters. Pursuant to the Agreement, FPA agreed that it will not purchase or acquire, directly or indirectly, any additional shares of Common Stock until the earlier of (i) September 28, 2016, or (ii) 72 hours after FPA provides notice to the Company that discussions have terminated.
