This Amendment No. 1 is being filed jointly by the Reporting Persons and amends the Schedule 13G initially filed by the Reporting Persons with the Securities and Exchange Commission (the “SEC”) on October 11, 2017 (the “Schedule 13G”).

Item 4. Ownership.

As of close of business on December 31, 2017, each of the Reporting Persons may have been deemed to have beneficial ownership of 909,090 shares of Common Stock issuable upon exercise of the Intracoastal Warrant, and all such shares of Common Stock in the aggregate represent beneficial ownership of approximately 5.7% of the Common Stock, based on (1) 15,095,867 shares of Common Stock outstanding on November 2, 2017 as reported by the Issuer, plus (2) 909,090 shares of Common Stock issuable upon exercise of the Intracoastal Warrant.
