\* In April 2001, Rateexchange Corporation (the Company) formed a wholly-owned subsidiary called RMG Partners Corporation (RMG). Pursuant to the Bylaws of RMG, Mr. Lillaney as Chairman of RMG had the sole and absolute discretion over the control and disposition of shares of Common Stock of the Company held by RMG that became Controlled Shares in accordance with an agreed schedule based upon the passage of time and achievement of revenue targets. As of June 30, 2001, 700,000 shares were Controlled Shares and thereafter additional shares became Controlled Shares based on RMG revenue so that, as of April 9, 2002, 1,149,876 shares of the Company's Common Stock were Controlled Shares. Assuming the Controlled Shares are considered beneficially owned by Mr. Lillaney, as of April 9, 2002 Mr. Lillaney had beneficial ownership of 1,157,976 shares of the Company's Common Stock (approximately 5.6% of the Common Stock).

In addition, pursuant to an Agreement dated April 8, 2001 between the Company and BL Partners LLC (BLP), BLP had an option exercisable at any time after the first anniversary of the date of such Agreement to acquire all of the Company's interest in RMG. In February 2002, BLP gave notice to the Company that it intended to exercise its right to purchase RMG on April 9, 2002 in accordance with the terms of the Agreement. BLP is controlled by Mr. Lillaney. On April 9, 2002 BLP exercised its option to purchase RMG, and on that date, the Controlled Shares were distributed to individuals such that Mr. Lillaney currently beneficially owns 673,776 shares of the former Controlled Shares, plus 8,100 additional shares of the Company's Common Stock, resulting in current beneficial ownership of 681,876 shares of the Company's Common Stock.
